## **Strategic Objective 1: Sustainable Communities**



Increasing effectiveness and efficiency of the water sector:

- Improved capacities of the water sector in 6 economies, through series of 26 national trainings and stakeholder forums, organised by NALAS member LGAs
- Developed advocacy strategies and policy papers for improving the water services in Bosnia and Herzegovina and Montenearo
- Strengthened institutional capacities of 13 partner Associations (LGAs and APUCs) through series of capacity development measures (training, mentoring, peer exchange), based on individual Association Needs Assessment

Increased Pool of Trainers, Moderators and Advisors, now bringing together 103 individuals

### Improving waste management:

- Developed and tested 5 methodologies for improving solid waste management services, related to: Optimisation of collection routes: Introduction of home composting: Optimisation of cost centres; Introduction of health & safety, and Optimisation of customer base.
- Improved solid waste management in 10 pilot municipalities from 4 economies, that resulted with savings of around 162.000 EUR



### Strategic Objective 2: Stable and Resilient Communities

#### Improving municipal capacities for **Disaster Risk** Management

- 3 municipalities in Albania (Tirana, Durrës and Krujë) were provided support in the earthquake response operations, with experts from North Macedonia. Slovenia and Turkey. with the assistance of ZELS. SOS and MMU.
- The first group of 11 experts successfully completed the NALAS e-Academy course in Disaster Risk Management.

Achieving **gender equality** at local level:

- Organised the first Forum of Women Mayors in SEE
- Upgraded the NALAS e-Academy course in Introduction to Gender Mainstreaming at Local Level





## **Strategic Objective 3: Improved Services**

SEE Local Government Associations and Local Governments emerging needs are met by a unique knowledge and evidence-based policy making and influence, through strategic regional and national partnerships.



Supporting LGAs advocacy efforts via the **Quick Response Service**:

- 8 national advocacy and lobbying activities supported with arguments and comparative data from all NALAS countries
- 3 of the processes were completed and resulted with protected independence and interests of local government



**Benchmarking** for improving local public services:

- Positive trends and challenges identified in the third issue of the Benchmarking Report on Solid Waste Management in SEE, this time extended with the issue of circular economy
- Strengthened group on Water and Sanitation, as part of the Solid Waste and Water Management Task Force



Localising Sustainable Development Goals (SDGs)

- Trained trainers for Raising Awareness for the SDGs at local level
- Published resource material for local governments: Handbook "Agenda 2030 in my municipality"

# **Online courses** made available via NALAS e-Academy

 Three courses delivered in autumn session: Gender, Asset Management and Disaster Risk Management - 76 nominated participants, 18 certified

# EU advocacy for **voicing** and **improving the position of local government** in South-East Europe:

- NALAS proposals regarding role and function of LGs in enlargement reflected in the CoR Draft Opinion on Enlargement Package 2019. NALAS mentioned *expressis verbis* point 27 and 51 (CIVEX-VI/042)
- NALAS has been recognised as a key partner for introducing local government aspect in the Berlin Process. Co-organised the Forum of Cities and Regions in the frames of the Poznan Summit 2019
- Key note speech of NALAS President during the EU Enlargement Days
- Commissioner Johannes Hahn addressed at NALAS General Assembly via video message
- A Working Group for Local Governments set up within DG NEAR





Ensuring **recognition** of the work done and **sustainability** of NALAS:

- NALAS products were promoted at several global events and recognised as key resource
- 4 new project applications have been developed and submitted, 2 were approved
- NALAS Revolving Fund provided support in the application process
- 22 issues of the electronic NALAS Digest have been published, informing on local government developments throughout SEE
